RESOLUTION NO. 2597

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, ADOPTING THE 2007 PARKS, RECREATION AND OPEN SPACE MASTER PLAN TO BECOME EFFECTIVE UPON ITS PASSAGE AND APPROVAL.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that it is in the best interest of the health, safety, and general welfare of the citizens of the City of Keller to adopt a parks, recreation and open space master plan as a planning tool for future parks and recreation development to meet the needs of the citizens; and

WHEREAS, the Parks and Recreation Board reviewed and studied the proposed plan as developed and presented by the consultants, Half Associates; and

WHEREAS, at a Special Board Meeting held on July 24, 2007, the Parks and Recreation Board conducted a public hearing regarding said Master Plan; and

WHEREAS, after all persons were given an opportunity to present testimony in a public hearing, the Parks and Recreation Board has concluded that adopting the 2007 Parks, Recreation and Open Space Master Plan as presented is in the best interest of the City and further, makes a unanimous recommendation to approve said Master Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby adopts the 2007 Parks, Recreation and Open Space Master Plan as presented.



Passed by a vote of 5 to 0 on this the 2nd day of October, 2007.


